**League 1:** 4u-5u-6u (Co-ed): Squishy balls, machine pitch(35 ft, 26 mph) and/or T used, no strike outs, every kid hits every inning, score is not kept, instructional league. Season begins early June, approx. 6-8 games; 1 game per week. All games played at Lenz Field & Sports Complex. Six year old girls may also sign up for this league.

**League 2:** Girls in grades 1st and 2nd (2008/2009 school year). 11 inch softball, coach pitch, no strike outs, score kept, season begins early June. Approx. 10-12 games. All games played at Lenz Field & Sports Complex. Coaches umpire. Cost \$50

**League 3:** Girls in grades 3rd and 4th (2008/2009 school year). Semi Player pitch, 11 inch softball, 35 ft. pitching distance, score kept, season begins mid to late May. Approx. 12 games. If pitcher walks the batter coach then pitches. All games played at Lenz Field & Sports Complex. Coaches act as umpires. Cost \$50

**League 4:** Girls in grades 5th & 6th (2008/2009 school year). Player pitch, 12 inch softball, 40ft pitching distance, score kept, season begins mid to late May. Approx. 12 games. All games played at Lenz Field & Sports Complex. Umpires are provided. Cost \$65

**League 5:** Girls in grades 7th & 8th (2008/2009 school year). Player pitch, 12 inch softball, 40ft pitching distance, score kept, season begins early to mid May. Approx. 12 games. All games played at Lenz Field & Sports Complex. Most Games played on Tuesday nights. Umpires are provided. Cost \$65.
