**Age Cut-offs: April 30, 2010.** The age your child will be on April 30, 2010 is the age he will play for Spring 2010. **League 1:** Machine pitch 4u & 5u (Co-Ed): Level 1 Squishy balls, machine pitch (35 ft and 26 mph) and/or T used, no strike outs, every kid hits every inning, score not kept, instructional league. Season begins late-May. Approx 8 games. All games played at Lenz Field & Sports Complex.

**League 2:** Machine pitch 5u & 6u boys: Level 5 Squishy balls, machine pitch (40 ft and 35 mph), 5 strikes then T, score kept, season begins late-May. Approx. 12 games. All games played at Lenz Field & Sports Complex.

**League 3:** Machine pitch 7u, 8u, & 9u boys. Hard balls, machine pitch (42 ft and 38 mph), strike outs, score kept, season begins late-May. Approx. 12 games. All games played at Lenz Field & Sports Complex.

These risks and dangers may arise from foreseeable or unforeseeable causes; and d) by my or my child's participation in the Activities and/or use of the facilities and/or equipment, I, individually and on behalf of my child, hereby assume all risks and danger and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, members, managers, employees of Lenz Field or Lenz Field and Sports Center, LLC, or any other persons.

I, on behalf of myself, my child, and the personal representatives and heirs of my child or me, hereby voluntarily agree to and hereby effectively do release, waive, discharge, hold harmless, defend and indemnify Lenz Field and Lenz Field and Sports Center, LLC and its owners, agents, officers, and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of baseball and softball training equipment or practice facilities or equipment my or my child's participation in the activities. I specifically understand that I am releasing, discharging and waiving any claim or actions that I or my child may have presently or in the future for the acts or other conduct by the owners, agents, officers, members, managers or employees of Lenz Field and Sports Center, LLC.

Should any provision of this Waiver and Release be determined unenforceable by a court of law, this Waiver and Release may be revised to waive and release my rights to the greatest extent allowed by law, since this is my intent in signing this document.
